Q. IS UNITED WAY A NATIONAL OR LOCAL ORGANIZATION?


A. United Way of Northern Arizona is a local, non-profit organization, governed by a group of dedicated volunteer community members.

Q. WHY GIVING TO UNITED WAY OF NORTHERN ARIZONA IS THE BEST WAY TO CONTRIBUTE IN OUR COMMUNITY.

A. Together, we will make a greater impact on creating an educated and thriving community – a community that ensures lasting change. Through collaboration we will combine resources and leverage our talents to drive broader social and systemic change in our community.

Community Investment Fund volunteers are recruited through our list of donors, campaign volunteers, and corporate and community leaders. They are tasked with reviewing applications and conducting site visits to UWNA-funded partners and, based on their exhaustive assessment, recommendations are submitted to the UWNA Finance Committee for review. Final decisions on the Community Investment Fund is made by the UWNA Board of Directors2

Q. IS MY UNITED WAY CONTRIBUTION TAX DEDUCTIBLE?

A. Yes, Charitable donations are after-tax. This included donations to the Arizona Charitable Tax Credit/Working Poor. Your charitable donations come out of your after-tax earnings, you can deduct the total amount deducted from your payroll checks during the year on the "Gifts to Charity" line of your Schedule A if you choose to itemize instead of claiming the standard deduction. If your employer matches your payroll donation, you can't deduct any of the matched donation -- only your employer can deduct that portion of the charitable gift.

Q. HOW IS UNITED WAY OF NORTHERN ARIZONA HELD ACCOUNTABLE?

A. United Way of Northern Arizona prides itself on being a trustworthy and accountable organization.

A volunteer committee of financial experts meets year-round, monitoring the organization's financial position. We maintain high standards of operation and are reviewed each year by an independent auditor, who verifies that our financial statements fairly present the financial position of United Way of Northern Arizona.

Q. How much of my contribution goes back to the community?

A. 89% of all funds raised is returned the community. Our operating ratios are as follows:

Fundraising	8%
Total Overhead Ratio	11%
